## **MODE OF MEETING**

#### REGISTRATION

- The registration counter will start at 12.00 p.m. on 7 May 2025 and will remain open until the conclusion of the RCUIDS Holders Meeting or such time as may be determined by the Chairman of the meeting.
- RCUIDS holders/proxies are requested to produce your original MyKad or Passport (for non-Malaysian) during registration for verification purposes. Please ensure the original MyKad or Passport is returned to you.
- Upon registration, you will be issued an identification wristband (printed with passcode).
   Please retain the same for entry to and for voting at the RCUIDS Holders Meeting of the Company. There will be no replacement in the event that you lose or misplace your identification wristband.

If you have any enquiry, please proceed to the Help Desk. The Help Desk will be located next to the registration counters.

### APPOINTMENT OF PROXY

 RCUIDS holders who wish to appoint proxy to attend the RCUIDS Holders Meeting must ensure that the duly executed Form of Proxy is deposited in a hard copy form at the business address of Malaysian Trustees Berhad at Level 11, Tower 3, RHB Centre, Jalan Tun Razak, 50400 Kuala Lumpur, Malaysia or by electronic lodgement via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> not later than 2.00 p.m. on 5 May 2025. Faxed copies of the duly executed form of proxy are not acceptable.  The appointment of a proxy may be made in a hard copy form or by electronic means in the following manner:-

# (i) In Hard Copy:

By hand or post to the business address of Malaysian Trustees Berhad at Level 11, Tower 3, RHB Centre, Jalan Tun Razak, 50400 Kuala Lumpur, Malaysia not less than forty-eight (48) hours before the time appointed for holding the RCUIDS Holders Meeting or any adjournment thereof, otherwise the Form of Proxy shall not be treated as valid.

# (ii) By Electronic Form:

All RCUIDS holders have the option to submit the Form of Proxy electronically via TIIH Online not less than forty-eight (48) hours before the time appointed for holding the RCUIDS Holders Meeting or any adjournment thereof. The steps to submit electronic proxy form are summarised below:

### **VOTING**

- Shareholders and proxy holders ("voters") are advised to download "Tricor e-Vote" apponto their smartphone/tablets ("devices") before attending the meeting.
- Tricor e-Vote app is available for download at no cost from Goole Play Store or Apple App Store.
- To use Tricor e-Vote, you need to connect to the Wi-Fi network provided by Tricor.
- On the meeting day, go to your device setting, choose the Wi-Fi name and enter the password to join:-

- Detailed instruction on how to vote will be provided in the meeting before the start of the voting session.
- Voting for all the resolutions set out in the Notice of RCUIDS Holders Meeting will take
  place concurrently upon the conclusion of the deliberations of all the business to be
  transacted at the RCUIDS Holders Meeting.
- Upon completion of the voting session for the RCUIDS Holders Meeting, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
