- Upon registration, you will be issued an identification wristband (printed with passcode).
   Please retain the same for entry to and for voting at the RCUIDS Holders' Meeting of the Company. There will be no replacement in the event that you lose or misplace your identification wristband.

### APPOINTMENT OF PROXY

RCUIDS holders who wish to appoint proxy(ies) to attend the RCUIDS Holders' Meeting

## (i) In Hard Copy:

In the case of an appointment made in hard copy, the original Form of Proxy must be duly executed and deposited at the business address of Malaysian Trustees Berhad at Level 11, Tower 3, RHB Centre, Jalan Tun Razak, 50400 Kuala Lumpur. Faxed, photocopied and electronic scanned copies of the duly executed Form of Proxy are not acceptable.

# (ii) By Electronic Form:

A confirmation email will be sent once approved.</li> <li>Once you receive the confirmation, activate your account by creating your password.</li> </ul> If you are an existing user with The Portal or the TIIH Online portal previously, you are not required to register again.		
(b)	Proceed with submission of Form of Proxy	<ul> <li>After the release of the notice of RCUIDS Holders' Meeting by the Company, login with your username (i.e. email address) and password.</li> <li>Select the corporate event: "CAPITAL A RCUIDS Holders' Meeting 2025 – Submission of Proxy Form".</li> <li>Navigate to the 3 dots at the end of the corporate event and choose "SUBMISSION OF PROXY FORM"</li> <li>Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>Indicate the total number of shares assigned to your proxy(s) to vote on your behalf.</li> <li>Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint the Chairman as your proxy.</li> <li>Indicate your voting instructions – FOR or AGAINST or ABSTAIN.</li> <li>Print the proxy form for your record.</li> </ul>

(a)	Register as a User at The Portal	<ul> <li>Visit the website at <a href="https://srmy.vistra.com">https://srmy.vistra.com</a>.</li> <li>Click "Register" and select "Representative of Corporate Holder" and complete the New User Registration Form.</li> <li>Complete the registration form with your personal details.</li> <li>Once registration is completed, you will receive an email notification to verify your registered email address.</li> <li>After verification, your registration will be reviewed and approval within two (2) working days. A confirmation email will be sent once approved.</li> <li>Once you receive the confirmation, activate your account by creating your password.</li> </ul> (Note: The representative of a corporation or institutional RCUIDS Holders must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration.)		
(b)	Proceed with submission of Form of Proxy	<ul> <li>Login to <a href="https://srmy.vistra.com">https://srmy.vistra.com</a> with your email address and password.</li> <li>Select the corporate event: "CAPITAL A RCUIDS Holders' Meeting 2025 – Submission of Proxy Form".</li> <li>Navigate to the icon "&gt;" at the end of the corporate event.</li> <li>Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>Select the corporate holder's name.</li> <li>Proceed to download the submission file.</li> <li>Prepare the file for the appointment of proxy(ies) by inserting the required data.</li> <li>Proceed to upload the duly completed proxy appointment file.</li> <li>Select "Confirm" to complete your submission.</li> <li>Print the confirmation report of your submission for your record.</li> </ul>

  place concurrently upon the conclusion of the deliberations of all the business to be
  transacted at the RCUIDS Holders' Meeting.

 Upon completion of the voting session for the RCUIDS Holders' Meeting, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
